
## Event Highlights:

# Executive Summary

The Muslim Trade Forum UK (MTF) successfully coordinated a landmark delegation of British Muslim business leaders to the Makkah Halal Forum held in Saudi Arabia from 22nd to 27th February 2025. This strategic engagement was envisioned as a foundational step toward launching the British Muslim Chamber of Commerce & Industry (BMCCI), which aspires to serve as a central body for promoting halal trade and investment between the UK and the Islamic world.

Throughout the visit, delegates engaged in dialogue with influential stakeholders, including global financial institutions, key Saudi ministries, and diplomatic officials. Notably, discussions with the Islamic Development Bank, the Saudi Ministry of Investment, and the British Consulate in Jeddah fostered critical momentum toward developing institutional partnerships and commercial linkages.

The delegation's participation extended beyond formal meetings. Members contributed meaningfully to global panels focusing on Halal sector innovation, ethical standards, and inclusive economic development. Exchanges with delegations from Central Asia, Africa, and the Balkans enabled rich bilateral dialogue that underscored the growing influence of the UK in the Halal economy.

This mission helped establish credibility for the British Muslim business sector on the world stage. The visit's outcomes have laid the groundwork for structured collaborations, positioning BMCCI as a future driver of sustainable halal commerce.


# Introduction

Through meaningful discussions, formal sessions, and side meetings with ministries, international chambers, and private sector leaders, the delegation championed the UK's intent to become a central player in shaping the future of Halal trade, investment, and policy alignment.

In essence, the delegation's presence at the Makkah Halal Forum was not just symbolic—it was a strategic milestone toward building a lasting institutional framework that fosters commercial cooperation, encourages entrepreneurship, and champions British Muslim business excellence on a global stage.

## Meeting 1: Meeting with Islamic Development Bank (IsDB)

- Hosted at IsDB headquarters in Jeddah.
- Delegation welcomed by Dr. Sami Al Suwailem – Acting Director General, IsDB.

### Objective:

To discuss investment opportunities, Islamic finance solutions, and UK participation in IsDB-backed Halal trade initiatives.

### Key Discussion Points:

#### IsDB's Role in Global Halal Trade

- IsDB provided an overview of its initiatives to support Halal industry expansion through investment and trade facilitation.
- The delegation explored funding opportunities for UK-based Halal businesses under IsDB programs.

#### Islamic Finance Solutions for SMEs

- Discussion focused on Shariah-compliant financial instruments, such as Murabaha and Sukuk, to support UK Halal businesses' growth.

#### Future Collaboration

- Agreement to explore joint projects in Halal food production, logistics, and certification standardization.
- IsDB invited MTF to participate in future IsDB trade initiatives.

## **Meeting 2: Meeting with British Consul General in Jeddah**

- Delegation met Ms. Cecille Elbeleidi – British Consul General in Jeddah at the British Consulate General in Jeddah.

### **Objective:**

To discuss the current state of UK-Saudi trade relations, opportunities for British businesses in the Halal sector, and strengthening bilateral trade and investment ties between the UK and Saudi Arabia.

### **Key Discussion Points:**

#### **UK-Saudi Trade Relations and Halal Industry Growth**

- The British Consul General provided insights into the growing demand for UK-based Halal products in Saudi Arabia and the Gulf region.
- Discussion on expanding UK exports of Halal food, pharmaceuticals, and cosmetics to Saudi Arabia.
- Emphasis on the role of Saudi Vision 2030 in creating a business-friendly environment for foreign investment, particularly in the Halal economy.

#### **British Muslim Chamber of Commerce & Industry (BMCCI) Establishment**

- Introduction of BMCCI as a platform to enhance trade and economic ties between the UK and Muslim-majority countries.
- The British Consul General expressed support for the initiative and recommended engagement with UK Department for Business and Trade (DBT) for further facilitation.

#### **Opportunities for UK Businesses at Future Saudi Trade Forums**

- Discussion on UK participation in upcoming Saudi trade exhibitions and investment summits.
- Encouragement for British Halal businesses to establish partnerships with Saudi investors.

### **Outcome:**

- UK Embassy to facilitate British businesses in entering the Saudi Halal market.
- Until the establishment of BMCCI, MTF to collaborate with UK Department for Business and Trade (DBT) for structured UK-Saudi trade engagement.
- Consulate staff assisted individual delegates with trade inquiries.

#### Collaboration on Halal Certification Standards

To establish an initial working relationship between MTF and the Islamic Chamber of Commerce, Industry & Development (ICCD) and explore areas of mutual collaboration in promoting Halal trade and investment.

### **Key Discussion Points:**

- ICCD aims to facilitate Halal trade and investment between OIC member states and global partners.

#### **Introduction of Muslim Trade Forum UK (MTF) and BMCCI**

- Over 1.9 billion Muslims worldwide represent a consumer market exceeding \$3 trillion.
- Muslim entrepreneurs are leading sectors such as finance, Halal food, pharmaceuticals, technology, and logistics.
- Collaboration between Muslim and non-Muslim business leaders is essential to create an inclusive and sustainable global economy.

- MTF to explore collaboration on digital transformation projects for UK Halal businesses.

## Panel Discussion: Empowering Women in Halal Business

### Objective of the Panel:

- To explore the critical role of women in the global Halal economy, identify challenges faced by women-led businesses, and discuss strategies for empowerment, financing, and global trade participation.

### Key Discussion Points:

#### Women's Role in the Halal Economy

- Deena Ataie emphasised that women entrepreneurs play a significant role in the growth of the Halal industry, particularly in Halal food, modest fashion, and ethical beauty sectors.
- She cited examples of women-led Halal brands in the UK making waves globally.

#### Challenges Faced by Women in Halal Business

*Panelists highlighted key barriers:*

- Limited access to financing for women-led Halal startups.
- Cultural and social restrictions in certain regions.
- Lack of structured mentorship programs for female Halal entrepreneurs.
- Regulatory challenges in exporting Halal products.

#### Key Takeaways & Commitments:

- MTF UK will establish a "Women in Halal Business" Network to provide mentorship, access to funding, and global market opportunities.
- Saudi Women in Business Association invited MTF UK to co-host a UK-Saudi Women's Halal Trade Forum in 2026.
- South Africa & Indonesia expressed interest in forming a Women's Halal Trade Alliance with the UK.



## **Meeting with Saudi Ministry of Investment**

The delegation met with Mr. Mohamed Alohaly – General Manager (Food & Agri Division) at Ministry of Investment, Kingdom of Saudi Arabia

### **Objective of the Panel:**

- To explore the critical role of women in the global Halal economy, identify challenges faced by women-led businesses, and discuss strategies for empowerment, financing, and global trade participation.

### **Key Discussion Points:**

#### **Investment Incentives for UK Halal Businesses in Saudi Arabia**

Mr. Mohamed Alohaly outlined the Vision 2030 investment incentives for UK businesses, including:

- 100% foreign ownership for Halal businesses in food, pharmaceuticals, and cosmetics.
- Tax exemptions for the first five years for Halal startups.
- Fast-track business licensing for British investors in the Halal economy.

#### **UK's Potential Role in Saudi Arabia's Halal Market**

MTF UK delegation highlighted the following sectors where British companies could invest:

- Halal Food Processing & Packaging – Establishing UK-Saudi joint ventures in Halal-certified processed foods.
- Islamic Fintech & Halal Banking – Saudi Arabia welcomed UK Islamic banks to open branches in Riyadh & Jeddah.
- Halal Tourism & Hospitality – Opportunities for British companies in Muslim-friendly tourism services.

### **Key Outcomes & Agreements:**

- Saudi Arabia invited British investors to the 2025 Riyadh Halal Investment Summit.
- MTF UK will facilitate a UK-Saudi Halal Business Roundtable in London.
- British Halal SMEs will be given a “Fast-Track” entry into Saudi Arabia’s investment framework.


- UK-Saudi trade & investment relations.

- British Halal brands can benefit from Saudi Arabia's Free Economic Zones, particularly in Jeddah and Riyadh.

### **Objective:**

- To discuss UK-Saudi trade enhancement and policies for foreign investment in the Halal economy.

### **Outcome:**

- Minister expressed full support for UK businesses entering Saudi Halal markets.
- Potential preferential trade agreements to be explored.

## Meeting with Secretary General of SMIIC – Mr. Ihsan Ovut

During the course of the 2<sup>nd</sup> Makkah Halal Forum, the British Delegation had the honor of meeting with **Mr. Ihsan Ovut**, Secretary General of the Standards and Metrology Institute for the Islamic Countries (SMIIC). The meeting provided a valuable opportunity to discuss the growing importance of harmonizing halal standards and certification processes across OIC member countries.

Mr. Ovut shared insights on the strategic objectives of SMIIC, emphasizing the need for international cooperation in developing unified halal standards to enhance trade, ensure consumer confidence, and promote quality assurance across borders. The British side expressed strong interest in exploring potential collaborations with SMIIC in areas of halal certification, capacity building, and technical alignment, especially in view of the UK's active halal market and its aspirations to deepen engagement with OIC economies. The exchange concluded on a positive note with both sides agreeing to remain in contact for future initiatives aimed at mutual benefit and standardization.

## Concluding Meeting with H.E Mr. Yousef Khalawi, Secretary General – ICCD

### Objective:

To discuss the strengthening of UK-Saudi trade ties, with a focus on Halal exports, investment cooperation, and SME partnerships.

- MTF to partner with ICCD in organizing the 1st London Halal Forum scheduled in London in November 2025.
- MTF to organize a designated British Pavilion at the 3rd Makkah Halal Forum scheduled in 2026.
- MTF to collaborate with UK Government to initiate the proceedings of British National Week which will comprise of several events mainly Exhibition, Workshops, Seminars, Conferences, Panel Discussions, etc. The first edition can be organised in Riyadh, Kingdom of Saudi Arabia followed by other editions in Jeddah – Kingdom of Saudi Arabia, Dubai – United Arab Emirates and Doha – Qatar.

### Outcome:

- Sir Iqbal Sacranie OBE – Chairman MTF UK and Leader of the Delegation assured the Secretary General ICCD that MTF will partner with ICCD in all these events.

# Key Achievements and Outcomes

---

The participation of the Muslim Trade Forum UK (MTF) delegation at the 2<sup>nd</sup> Makkah Halal Forum was a highly successful endeavor, resulting in several significant achievements across multiple domains, including trade facilitation, investment opportunities, strategic collaborations, and policy dialogues. The delegation's engagement with government officials, business leaders, and trade organisations laid a strong foundation for long-term cooperation between the UK and OIC (Organization of Islamic Cooperation) member states in the Halal industry.

## **Strengthening UK's Position in the Global Halal Economy**

- One of the most crucial achievements of the forum was positioning the UK as a key player in the global Halal market. The discussions with the Islamic Chamber of Commerce, Industry & Development (ICCD), the Saudi Ministry of Investment, and the British Consul General in Jeddah highlighted the potential for UK-based Halal businesses to expand their footprint in the Middle East, Central Asia, and Africa.
- The Saudi Ministry of Investment confirmed that UK businesses are highly regarded in the Halal sector, particularly in food processing, pharmaceuticals, and cosmetics.
- MTF successfully advocated for preferential trade facilitation mechanisms for British Halal-certified businesses in Saudi Arabia.
- The ICCD extended an invitation for MTF to become an official partner in its international trade facilitation programs.

## **Establishing Direct Business and Investment Partnerships**

- During the B2B meetings and panel discussions, the delegation facilitated direct trade connections between UK companies and potential buyers, distributors, and investors from Saudi Arabia, Azerbaijan, Uzbekistan, Nigeria, and Bosnia.
- Azerbaijan expressed strong interest in partnering with UK firms for Halal logistics and supply chain development.
- Nigeria sought collaborations in Halal-certified meat exports to the UK, given the country's vast livestock industry.
- Uzbekistan is keen to import British Halal-certified products and standardize its Halal certification system in alignment with the UK's rigorous food safety standards.
- Bosnia invited UK investors to explore Halal tourism and hospitality projects in the Balkan region

## **Securing Institutional Collaborations**

One of the most promising outcomes was the establishment of institutional-level collaborations between MTF and:

- The British Consul General in Jeddah, who committed to supporting UK Halal businesses in Saudi Arabia.
- The Islamic Chamber of Commerce, Industry & Development (ICCD), which invited MTF and BMCCI to join its trade initiatives.
- The Saudi Minister of Commerce, who expressed his willingness to facilitate UK-Saudi Halal trade partnerships.
- These collaborations will pave the way for structured engagements, including joint trade missions, investment forums, and regulatory harmonization efforts.

Exhibitors from a wide array of nations took part in the event, including **Saudi Arabia, Indonesia, Azerbaijan, Türkiye, Malaysia, Brazil, Thailand, and South Africa**—each presenting their country's expertise and innovation in halal production and compliance. The United Kingdom was also prominently represented through **Al-Wadhiyah**, a leading UK-based halal enterprise known for its commitment to Shariah-compliant standards in production and distribution.

The exhibition demonstrated the inclusive and expansive nature of the halal industry, underlining its relevance not only to Muslim consumers but also to global markets focused on ethical, safe, and traceable products. It served as a unique platform for dialogue, knowledge exchange, and cross-border collaboration, strengthening Makkah's emerging role as a central hub for the global halal economy.
